

Spring 2019 Society Meeting

The Junior Membership has been having a reasonably successful year navigating their suspension. As predicted, the loss of a pledge class is having a significantly negative impact on RSE JM operations.

After reviewing the various officer reports the team separated into our Task Forces. Cary Nadel '77, Eric John '95 joined our Live-In Advisor Pete Liporace to work on the Reinstatement Plan. The Dean of Students Office currently requires that RSE completes a substantial document to apply for re-admission to Greek life. Current RSE JM President Jack Graham '21 has led the JM EComm in separating this daunting task into smaller sections. At this time, we have made our initial submission, with inevitable revisions expected before we are approved in the fall.

While that group was working, Don Thoma '83 joined Rush Chairman Jake Hodgson '20 and the JM team to continue working on the Rush Plan for Fall '19. As RSE has continued to develop our core values, this has impacted the Rush goals. RSE will continue to recruit students of character, in accordance with the school guidelines. QUALIFIED CHARITABLE DISTRIBUTIONS (QCD)

Donating to the RSE Foundation using a Qualified Charitable Distribution (QCD)

An interested RSE alumnus recently provided us with some insight about Qualified Charitable Distributions (QCD) given the impact of the new federal tax laws on deductions, charitable giving, and required minimum distributions (RMD) from IRAs (and similar deferred accounts). With the important caveat that the following is not tax advice and every situation is different, we wanted to pass this information along.

In 2018, the IRS rules changed significantly including raising the standard deduction to \$12,000 for single filers and \$24,000 for married couples filing jointly. In some cases, filers find that foregoing itemizing deductions and taking the standard deduction is a better option. Without itemizing, it is generally not possible to realize a deduction for charitable contributions to organizations such as The RSE Foundation, a recognized 501 (c) (3) organization.

"If you are age 70¹/₂ or older, IRS rules require you to take required minimum distributions (RMDs) each year from your tax-deferred retirement accounts. This additional taxable income may push you into a higher tax bracket and may also reduce your eligibility for certain tax credits

SCHOLARSHIP DRIVE UPDATE

RSE Foundation Scholarships Update

The RSE Foundation made a special appeal in our December 2018 letter with the specific goal of growing the value of individual scholarships. We are pleased to announce that, through your generosity, our alumni have raised more than \$5000.

The RSE Foundation announced the schedule for scholarship applications during the Spring 2019 Society meet-

ing in Troy. The Foundation works closely with the Junior Member President to facilitate

applications for our five scholarships. The awardees will be announced in the Fall, during the Society meeting. and deductions. To eliminate or reduce the impact of RMD income, charitably inclined investors may want to consider making a QCD.

A QCD is a direct transfer of funds from an IRA custodian, payable to a qualified charity (such as The RSE Foundation), as described in the QCD provision in the Internal Revenue Code. Amounts distributed as a QCD can be counted toward satisfying your RMD for the year, up to \$100,000, and can also be excluded from your taxable income. This is not the case with a regular withdrawal from an IRA, even if you use the money to make a charitable contribution later on. In this scenario, the funds would be counted as taxable income even if you later offset that income with the charitable contribution deduction.

Why is this distinction important? If you take the RMD as income, instead of as a QCD, your RMD will count as taxable income. Having higher taxable income can directly impact your eligibility for certain deductions and credits. For example, your taxable income helps determine the amount of your Social Security benefits that are subject to taxes. Keeping your taxable income level lower may also help reduce your potential exposure to the Medicare surtax."

The 150th Society Reunion in October 2016 with its huge turnout was fantastic, but five days together with former roommates was an experience they'll never forget. Pleasant memories of experiences in the house came flooding back, and while the four Coolies did debate Fox News vs. CNN, they put politics aside to thoroughly enjoy one another's company once again. The Coolies highly recommend similar reunions for all RSE brothers.

Over the past year, the Trustees have been discussing and finalizing the revised Mission and Vision Statement of the Society. RSE continues to evolve during its 150 years of existence and we felt it is important for us

to ensure the Mission and Vision Statements provide us with a unifying context for the future. Here is a summary of the revised Mission and Vision Statements for the Society.

PROPOSED MISSION STATEMENT

"Engage and connect all Members of The Rensselaer Society of Engineers collaboratively in a meaningful, lifelong brotherhood - to perpetuate our independent Society, by instilling our core values of service, leadership, personal growth, and the pursuit of knowledge."

For those of you who have created mission statements before, they can be a mind-numbing task where every word is carefully chosen, (by a group of people!) to summarize the most important characteristics of the organization. The RSE mission statement is no different. Here is some of the explanation why the language was chosen.

The Society is a forum for "engaging" our members, both undergraduate and alumni, though events, communications, etc. RSE is also a resource for "connecting" members to each other, possibly for the first time or as a return after a long time apart (i.e. the 150th Celebration, our proposed Networking Forum, the RSE Speaker Series, etc.). The words "all Members of The Rensselaer Society of Engineers collaboratively" shows that we want to be inclusive of "all" members, JMs and alumni. The words "meaningful lifelong, brotherhood" speaks for itself and tells us what we are. RSE is not for the three plus years at RPI. RSE is for life. The words 'independent Society" were thought to be very important to who we are at our core. We are the only "independent" fraternity at RPI (both financially and through governance) and this should be reflected in our Mission. We end the RSE Mission Statement with the thought of "instilling our core values of service, leadership, personal growth, and the pursuit of knowledge." After much debate, we felt that these represent the key core values that encompass all of RSE and what it stands for. We feel that they are both specific enough to identify who we are and what we stand for, yet flexible enough to be expandable and open to interpretation in each category.

VISION STATEMENT

"Significantly contribute to academic, local, and long-term communities through a unified and vibrant Society."

The Vision Statement represents the aspirational, global goal for RSE. The vision statement represents what our experiences at RSE translate to as we move beyond RPI. It is how we use these skills and experiences to build our careers and live our lives, with the ultimate aim of giving back to our communities.

ALUMNI REUNION

Update on the Greek Life Task Force and What It Means for RSE

As many of you know, last year RPI convened the Greek Life Task Force (GLTF). The purpose of the GLTF is to determine how to improve the long-term sustainability of the Greek system, move the Greek system to a community that promotes good citizenship, and find a way to keep the strong chapters strong and help the weaker chapters improve.

For more than 165 years, Greek Life at Rensselaer Polytechnic Institute has played an important role in elevating the student experience: enriching student's lives, creating great resources for philanthropic causes, and dramatically accelerating the successful careers of Alumni. However Greek Life at RPI is showing signs of deterioration, similar to the problems that have impacted Greek Life at other universities. The school decided to convene the GLTF to help address the underlying causes of these problems before they have a tragic impact at RPI.

The GLTF consisted of a committee of school officials, students, alumni and alumnae and external experts whose charter was to review Greek Life at RPI and make recommendations on areas of improvement. The GLTF met on a regular basis throughout 2018 using facilitated campus discussion groups, convened external panels and provided community briefings on the progress of the GLTF. The GLTF proposed a set of recommendations to strengthen and protect the Greek community centered around four key areas: 1. Improving behavioral issues; 2. Addressing health and safety deficiencies; 3. Improving the financial viability of all chapters; and 4. Creating uniform and transparent measures of success:

- Incorporate CLASS (Clustered Learning, Advocacy, and Support for Student) Goals and Practices into Greek Life
- 2. Strengthen Finances, and Improve Health, Safety and Behaviors
- Establish Stronger Relationships through the Timing of Recruitment and Intake
- 4. Mitigate High Risk Behaviors, Alcohol and Substance Abuse
- 5. Integrate the Greek Life Commons and The Arch
- 6. Foster an Intentional Emphasis on Diversity and Inclusion
- 7. Develop a New Transparent Scorecard
- 8. Merge all Greek Life Agreements
- 9. Redefine the Student Judicial System
- 10. Build Trust, Leadership, Integrity and Accountability

The goal of these recommendations is to help every house and chapter have the tools to fulfill their stated missions and continue to instill the Greek values including a sense of family, service to the community, and leadership skills in its members. The final report has been presented to President Jackson and we expect to see the implementation of most, if not all, of these recommendations by RPI. So, what does this mean to RSE? Since we are developing and executing our program to come off suspension, we have been implementing many of the recommendations already, including having a live-in advisor, updating our recruitment program and having an alcoholfree house. The last area is important as it is the main reason for RSE's suspension. No Alcohol will be allowed in

RSE, under any circumstances! Period! Even if you are an alumnus and are over 21!

One benefit of these recommendations is that it will provide a consistent framework for all Greek Life at RPI. However the shift of recruitment for incoming freshmen to the spring semester will have a significant impact. Since we missed the Fall 2018 rush, this will make it 18 months since we had new members join, putting pressure on the JMs for a quality rush when it happens. We are also evaluating the impact of integrating the Greek Life Commons and the Summer Arch, which could have a positive impact of allowing members to live-in during Arch.

Change is hard, but recent events at other universities have the potential impact of destroying the Greek system entirely if they occur at RPI. It is better that RSE embrace the changes and help mold them to reinforce the values of our Society and ensure that RSE will last another 150 years.
